

The Mediterranean Coastal Cliffs Preservation Government Company Ltd (hereinafter: "MCCP")

Public Request for Information ("RFI")

For locating sources of marine /land sand for the activities of MCCP and transportation

1. Introduction

1.1 The Mediterranean Coastal Cliffs Preservation Government Company Ltd. (hereinafter: "**MCCP**") was established in accordance with a government decision for planning, execution, maintenance, and management of marine protection and management, supervision, and consulting for land protection, regarding the collapse of the coastal cliffs in Israel.

MCCP hereby invites participants with the required abilities who wish to participate in RFI to submit the relevant information required by MCCP for the purpose of the allocation of sources of sand, for marine protection projects carried out by MCCP.

- 1.2 For this purpose, MCCP is issuing the RFI that is mainly intended to locate sand from marine and/or land sources for the purpose of placing and spreading sand nearby breakwaters in marine projects managed by MCCP.
- 1.3 Each participant in this RFI is invited to submit information regarding its proven capability of supply of sand, execution of dredging for the purpose of land reclamation /sand placing and spreading, and means of transportation, for the purpose of transporting the sand to a fixed location in the Israeli coastline as set forth in this document below.
- 1.4 This RFI is based on the location of sand placing and spreading in the Herzliya site, with placement on the shore or in a sand storage site as marked on the maps (attached hereto as Appendix A), based on which the participants are invited to submit the information.
- 1.5 **Availability for execution**: within 6 months from the work order.
- 1.6 Quantity 1 million m³ for every proposal, including the supply to a location in Israel within one year. Option an additional million m³ under the same conditions within two years of completion of supply of the first quantity.

2. Timetable for the receipt of the information

- 2.1 The last date for submission of questions by the potential participants is not later than September 12, 2022 (hereinafter: "clarification questions").
- 2.2 The last date for submission of the information by the participants October 31, 2022 (hereinafter: "the last date for submission").



2.3 MCCP shall be entitled to change the timetable and/or to update it, including to extend the date specified for submission of the information, without reducing MCCP authority to examine the proposal submitted for examination at any time.

3. Clarification questions

- 3.1 The participants may submit request for clarification in writing to the coordinator of the Tenders Committee via email Tamar@mccp.co.il not later than the data as set forth above.
- 3.2 MCCP's response to clarification questions shall be published on the MCCP Website www.mccp.co.il without the need to directly contact the participants.

4. Submission of the information

4.1 **The date of submission** – The participants are requested to submit the information including all the required details to a designated mail box RFI2@mccp.co.il or to MCCP's offices, at 4a Hatzoran 57, Netanya, after coordination in advance with MCCP by email message sent to Tamar@mccp.co.il

Every participant shall submit documents attached to its submission and shall attach all the required documents as listed, not later than the date as set forth above.

4.2 The method of submission of the information and the documents required for submission of the information:

- 4.3 The participants are entitled to submit information about one or more projects, including documents, regarding the source and the quality of the sand, legal status or other regarding the supply of the sand.
- 4.4 The participants in the RFI shall be permitted to submit an any giving information of one or more sources of marine and/or land sand, while giving a declaration regarding the legal and ownership capability to make an agreement with MCCP that wishes to purchase the sand.
- 4.5 Every participant has the option of attaching and/or submitting experience in execution of excavation and/or laying of the sources of the sand for projects managed by MCCP.
- 4.6 The participants shall complete all the required fields, giving details of the following data (**in accordance with Appendix B attached hereto**):
- 4.7 **Location of the sand** Every participant shall submit documents that support its ability of proposing the sources of the sand, marine excavation or land mining in accordance with the location of the sand, marine or land transportation and supply of the sand to the site in Herzliya, as specified by MCCP and as marked on the maps.
- 4.8 **Details of the participants** Every participant shall submit the information giving details of the name of the participant, the corporation registration number, its legal



registration status in the location from which supply of the sand will be made, and the location of its head offices. The bidder is required to declare that it holds approval for mining the sand in the source country, and supplying it to Israel, and that it holds the resources require for handling the sand.

- 4.9 Characteristics of the quality of the sand Every participant shall submit the tests carried out based on the requirements attached to this document as Appendix C (hereinafter: "the document: examinations required for import of sand for feeding shores").
- 4.10 **Availability for execution**: within 6 months of the work order.
- 4.11 **The resources required for handling the sand** Including details of the means for handling, the date of supply, and all the details.
- 4.12 **Estimation of the consideration** Every participant shall present an estimation of the consideration (price list) based on measurement, for every m³ of sand to be supplied, by marine or land location. The estimation of the consideration shall be submitted as a price not including VAT.

5. The RFI of examination of the information

- 5.1 MCCP shall be entitled, and every participant gives its consent, in an irrevocable and unreserved way, to examine and carry out any test by professional entities and/or by means of a laboratory, including whether the sand supplied is suitable for the projects managed by it. MCCP shall be entitled to verify the information provided by one or more participants, at its sole and absolute discretion, taking into account the reasonableness of the information, that it shall be possible to meet the supply of the sand in the quantity and scale required by MCCP. The criteria for examination shall be determined at its sole and absolute discretion and in accordance with various characteristics including the quality of the sand, its location, and its availability for execution of the work.
- 5.2 MCCP shall be entitled to examine the information and request to receive clarifications from every participant for supply of the sand, taking into account the relevant data regarding the quality of the sand, laboratory tests, costs of handling, the quantity of the sand for supply and additional conditions to be determined by MCCP. However, MCCP is not obligated to continue to the stage of the thorough examination and/or to examine any proposal whatsoever.
- 5.3 MCCP shall be entitled to invite any relevant participants, at its sole and absolute discretion, for the purpose of submission of additional details for the purpose of thorough examination in accordance with the criteria specified by MCCP. MCCP reserves the right to examine the suitability of every proposal or participant, considering the identity of the participant and/or the method of submission of the proposal and the information to be submitted in it.



6. General conditions

- 6.1 This RFI is not part of a tender procedure or a competitive process and it does not create any obligation by MCCP whatsoever *vis-a-vis* any of the participants. Following the receipt of the information MCCP shall consider continuation of its activities in the subject of the request, if at all. However, a response to this request shall not award any advantage or exclusivity and it shall not guarantee compliance with the threshold conditions or any other condition.
- 6.2 Nothing said or not said shall obligate MCCP regarding a tender and MCCP shall be entitled to conduct negotiations with any of the participants or to make an agreement with any of the participants or to make some other kind of agreement, subject to the provisions of the law.
- 6.3 This RFI shall not create any obligation whatsoever by MCCP for the inclusion of any proposal whatsoever in a future agreement. The aim of the RFI is to examine as far as possible proposals for the supply of the sand for the benefit of projects carried out by MCCP and their inclusion in the examination only.
- 6.4 MCCP shall document all information received and every discussion held with those that responded to the preliminary RFI, in accordance with criteria relevant for advancing projects carried out by MCCP, and MCCP shall be entitled to contact one or more participants and receive additional clarifications regarding the information, from those who replied to the RFI or from other bodies, all as it sees fit, as required at its sole and absolute discretion, and in accordance with orders of priority in projects managed by it.
- 6.5 If MCCP should decide to proceed to an additional competitive stage, MCCP shall be entitled to demand additional or different conditions from those appearing in the RFI, at its sole and absolute discretion, whether or not relying on sources of the information for the sake of the process.
- 6.6 MCCP shall be entitled to use the data from the proposals submitted by the participants, except for the prices or any professional secrets. Any information provided by the participant, based on which a tender may be conducted in the future, shall be disclosed if such participant (who submitting the relevant information) will be announced as the winning Bidder.
- 6.7 MCCP shall be entitled to issue reports and manage quality criteria, including to srt up a database of bidders if it should see fit. However, the submission of a proposal soes not create any contractual obligation whatsoever with MCCP, and this RFI does not award the participants any right of any kind whatsoever. The agreement if approved shall be made based on the needs of MCCP and in accordance with any geographic condition in which MCCP shall be carried out projects. The participants shall have no complaint and/or demand in connection with the RFI and submission any information whatsoever.

- 6.8 MCCP may make internal use of any information submitted by one or more participants, in whole or in part, as it sees fit.
- 6.9 Each Participant shall undertake as part of the information submitted and/or any use to be made of it, all rights shall not be harmed, including copyrights or commercial secrets of any third party. The participant who submitted information in the response to this RFI shall bear sole responsibility for any demand and/or claim originating in the allegation that third party rights as aforesaid were violated by it.
- 6.10 All the details to be submitted in any proposal shall be used for the internal use of MCCP, without the participants being entitled to consideration for the information and without MCCP undertaking to make an agreement and/or pay for the proposal and/or the supply of the sand in respect of it. The participants shall not be entitled to any compensation or indemnification or return or any payment whatsoever from MCCP, and all the costs involved in preparation of the response, collection and transfer of the information and its submission shall be at the sole responsibility of the participants and at their expense.
- 6.11 The RFI process and the transition of the participants between the stages shall not constitute a commitment by MCCP to make a future agreement. MCCP is not obligated to publish a competitive process to receive proposals. If it should choose to do so, a response to an earlier request shall not constitute a pre-condition for participation in a competitive or other process held following it and shall not award any advantage in a tender process to anyone who responded to the RFI, only because it did so.
- 6.12 MCCP shall be entitled to act in additional ways to locate sources of the sand and there is no exclusivity to the information nor to the sources of the sand proposed by those participating in this RFI.
- 6.13 This RFI is intended for participants in Israel and abroad. In the event of any inconsistency, the Hebrew language version shall be prevailed.
